As we rely solely on information provided by those wishing to surrender their dogs, we cannot guarantee the genetics, health or disposition of the dog, and we **STRONGLY** advise any prospective 'adopter' to get as much information as possible before adoption, to make sure that a dog will be the correct match for your circumstances and environment.

Compassion and patience are recommended, as any transaction can be both stressful and confusing for dogs who may have already suffered considerably.

Accidents and misunderstandings can and regularly do happen, until a new bond of trust and mutual respect can be established. Love and understanding will develop and blossom giving each new 'mum and dad' and their adopted Shar Pei the love they richly deserve.

Any member of the Committee will always be ready to help, should you need any assistance or advice, particularly in these early stages.

We respect your privacy. Any personal information provided by you, will be used solely by the Midland Shar Pei Club, for our own internal purposes, and where appropriate, to contact you directly.

Your personal information will not be sold or distributed to anyone else for any reason.

The Midland Shar Pei Club Welfare and Rescue fully assigns and releases to the undersigned individual {the Assignee} the ownership of and full responsibility and liability for the following Shar Pei:

I.....warrant that I understand and agree to accept and abide by the following terms and conditions in making this contract, and of accepting assignment from the Midland Shar Pei Club Welfare and Rescue of the dog described above.

I agree to accept full responsibility for maintenance and care of this Shar Pei, giving nourishing food, daily fresh clean water, regular grooming, sanitary living conditions, positive interaction, humane treatment, and shelter from all of the elements. I agree never to allow this dog to be chained or tied outdoors for any length of time, and I will never allow this dog to be involved in any altercation with another animal, whether on purpose, by accident or otherwise.

In order to prevent this dog from being transferred to a series of owners, and placed beyond the ability of the Midland Shar Pei Club Welfare and Rescue to intervene if the dog needs future help to prevent neglect/and or abuse, the assignee **MAY NOT TRANSFER** ownership or possession of this dog to anyone without first allowing the Midland Shar Pei Club Welfare and Rescue the right of first refusal and at the Midland Shar Pei Club Welfare and Rescue's choice, either reclaim the dog or approve the ownership change

I agree that the sum of money donated for the assignment of this dog is **NOT REFUNDABLE**, under any circumstances or for any reason.

I understand that the Midland Shar Pei Club Welfare and Rescue make **NO** guarantees, warranties or representations **WHATSOEVER** as to the health, temperament, habits, behaviour or other aspects of the dog. The dog is transferred in an "AS IS" condition. The assignee accepts the dog at **HIS/HER OWN RISK**, accepts all legal liability of ownership, and releases the Midland Shar Pei Club and its representatives from any liability related to this dog.

### **CODE OF CONDUCT ( CLUB RULE 11)**

The following Code of Conduct shall be adhered to at all times and if in the opinion of the Club Council, as decided at one of its meetings, when two thirds of the members are present and voting giving a majority vote, the council feels that any part of the Code has been broken. I understand that I shall be subject to censure and expulsion from the Club membership under rule 15.

#### **CONDUCT**

- (a) I shall at all times co-operate and participate with the Midland Shar-Pei Club and share aid and information with all those who have genuine interest in the Shar-Pei breed.
- (b) I shall at all times maintain the highest possible standard of care, health and welfare of all Chinese Shar-Pei in my charge.
- (c) I shall at all times encourage and exhibit sportsmanlike conduct in competitions and shall not display any derogatory manner or speech with regard to any other exhibitor or their dogs.

#### **BREEDING**

- (a) I will only Breed or attempt to breed from dogs and bitches which I consider to be good representatives of the Chinese Shar-Pei breed. I understand that it is of the utmost importance that breeding will only be undertaken for betterment of the Chinese Shar-Pei breed to produce typical sound and healthy stock.
- (b) I will not breed with any dog or bitch which has a proven hereditary defect at the time of mating.
- (c) I will breed only with bitches which are physically sound, in good health and of an acceptable temperament. I will only use or allow to be used, stud dogs which are physically sound, in good health and of an acceptable temperament.
